



# NOTICE OF RACE DISTRICT CHAMPIONSHIP NO-GAS REGATTA

## 1. RULES

- 1.1. The combined District Championship and No Gas Regatta will be governed by the 2021-2024 Racing Rules of Sailing, the Severn Sailing Association 2022-2024 Notice of Race and Sailing Instructions available at <https://www.severnsailing.org/s/SSA-NoR-SI.pdf> and this Notice of Race and Amendments to the Sailing Instructions.
- 1.2. In case of a conflict among these, the order of precedence is this Notice of Race and Amendments over the SSA Sailing Instructions over the RRS.

## 2. COMMUNICATION

- 2.1. Race Committee notices and Changes to the Sailing instructions will be posted on the official notice board under the SSA deck.
- 2.2. Paragraph 13.5 of the SSA SIs is modified as follows: The Race Committee will attempt to notify OCS (On Course Side of the starting line) boats by hailing bow or sail numbers, orally and/or on marine VHF channel 65A. Use of hand-held VHF radios will be permitted for communication from the Race Committee to competitors on channel 65A and for emergency communications from competitors to the Race Committee. Failure to receive a hail, for a hail to be made, the order of hails made, or to receive other communications to the fleet shall not be grounds for redress.

## 3. ENTRY AND REGISTRATION

- 3.1. Registration must be made on-line at <https://club.severnsailing.org/event/1318> and the registration fee of \$125 must be paid. This changes paragraph 5.1 of the SSA SIs.
- 3.2. No registrations will be accepted after 1700 hours June 10 and no on-site registrations accepted.

- 3.4. All skippers must sign a COVID-19 waiver for themselves and their crew. All skippers and crew must abide by the Severn Sailing Association rules shown below and at:  
<https://www.severnsailing.org/breeze/7v08zugcn9encu5mlazai2beibiwk3-2kpf5>, i.e., masks optional, come to SSA only if you are healthy with no symptoms of COVID-19 for the past two weeks and have not been exposed to anyone with COVID-19 symptoms in the past two weeks. Note: COVID restrictions are subject to change. Check the club website <https://www.severnsailing.org/breeze> for the up-to-date COVID policy and information.

## 4. SCHEDULE

- 4.1. Registration ends on June 10, 2022 at 1700 hours.
- 4.2. A skipper's meeting will be held on Saturday, June 11 at 0930 either on the club steps or via VHF channel 65A.
- 4.3. Schedule of Races:  
Saturday, June 11: 1100 First Warning Signal; 3 races anticipated  
Sunday, June 12: 1000 First Warning Signal; 2 races anticipated
- 4.4. No Warning Signal will be made after 1400 hours on Sunday. This changes paragraph 7.2 of the SSA SIs
5. **AMENDMENTS TO THE SAILING INSTRUCTIONS**
  - 5.1. Mark S may be an orange flag on a race committee boat or a tall yellow cylinder. This changes paragraphs 11.2 and 13.2 of the SSA SIs.
  - 5.2. The time limit is 1-1/2 hours for the first boat to finish. This changes paragraph 16.1 of the SSA SIs.
  - 5.3. Penalty system – Appendix V (Alternative Penalties) is in effect.

### **PRACTICAL INFORMATION (Not part of the Notice of Race)**

#### **Food/Social Activities:**

- Lunches are not available from the snack bar. A light continental breakfast will be available both days.
- Dinner for Skipper and Crew will be provided on Saturday after racing.
- Note that the SSA liquor license requires that **all** alcohol consumed on the SSA premises—clubhouse and lot—must be purchased from SSA official vendor.

**Housing:** No housing will be offered due to COVID-19.
